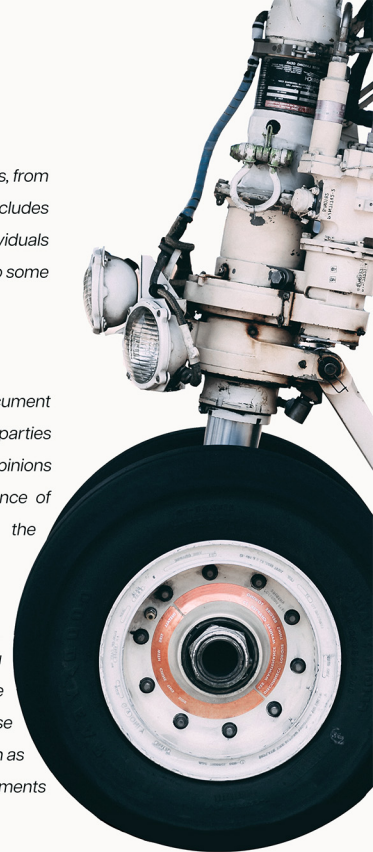

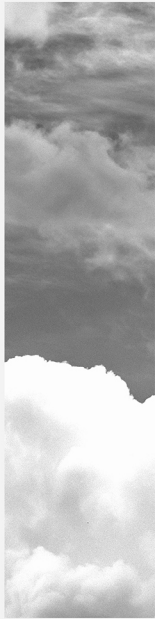
Security of funds.
